Booth Specifications

- Inside spaces are 10 ft. across the front, 8 ft. deep
- Exhibitor to furnish all decorations, dividers, tables & chairs
- Front of booth and first 4 ft. from aisle will not exceed 4 ft. in height
- Exhibit tables must be skirted to the floor or ground
- Dividers should be made of solid material
- Outside space size varies & billed accordingly

- No nails or dividers to be left in building at conclusion of Fair
- Inside spaces come with two 110 outlets
- Electric is available to outside spaces
- No subletting of space

ITEMS NOT ALLOWED TO BE SOLD, DISPLAYED OR DISTRIBUTED ON THE FAIRGROUNDS:

- * Drug paraphernalia
- * Obscene literature/merchandise
- * Aerosol novelty spray (such as silly string)
- * Paintball guns and related products
- * Frisbee's
- * Smoke bombs, stink bombs
- * Candy cigarettes or E-cigarettes
- * Coin operated machines (ie: Bubble Gum)

- * Alcohol
- * Explosives or exploding devices
- * Laser lights or related products (such as laser light pointers)
- * Tobacco or tobacco related products (including lighters)
- * Lotteries, raffles or any other games of chance
- * Swords, knives, guns, throwing stars, & other weapons (Real OR Toys)
- * Helium balloons
- * Cannabis, marijuana and/or related products and paraphernalia

There will be **NO**: lotteries, raffles, or any other games of chance; petitions; animals, pets or fowl in the commercial exhibit areas (except for pre-approved demonstration animals); reservation of parking spaces in the reserved parking area; smoking in exhibit buildings or tents. No pop up tents inside buildings.
